- **Agreement for the organization of the G7 summit in Biarritz from 24 August to 26 August 2019 with the Ministry of Europe and Foreign Affairs**

<b>Purpose of the agreement and financial conditions</b>	Agreement concluded between Orange SA and the Ministry of Europe and Foreign Affairs on behalf of the French State, within the framework of the organization of the G7 summit in Biarritz (France) under the terms of which Orange SA undertakes to provide technical services in the form of investments and infrastructure related expenses (mobile coverage, network, etc.) as well as the services delivered (voice and data services, WiFi, LAN, etc.) and " Program Management Office " services for a total amount of approximately 10 million euros.
<b>Benefits of the agreement for Orange SA and its shareholders</b>	Participation in the organization of the French presidency of the G7 allowing to contribute to the attractiveness of France.

- **Agreement for the requirements of the universal exhibition Dubaï 2020 with Compagnie Française des Expositions (COFREX), company completely owned by the French State**

<b>Purpose of the agreement and financial conditions</b>	<p>Agreement entered into with COFREX as part of the preparation and organization of the French participation to the Dubai 2020 Universal Exhibition under the terms of which Orange SA undertakes notably to providing a mobile phones fleet, to achieve the equipment of the network coverage and connectivity equipment for the entire "Pavilion France", and various services such as supplying and installing dedicated equipment as well as their cabling and their interconnection.</p> <p>The valuation of the services to be performed and the services to be provided for Orange is approximately 1.8 million euros for the "Pavilion France" of the Dubai 2020 Universal Exhibition, Orange benefiting from the status of "Ambassador of the French Pavilion». In its capacity as a partner company.</p>
